## Legislative Update

### Bills Affecting BPELS

CalGeo has been watching two legislative items that have been in committee the last couple of weeks that affect Board for Professional Engineers and Land Surveyors (BPELS). The first was SB 275, which would have elevated the "Title Act" level licenses (e.g. Traffic Engineer) to the "Practice Act" level (e.g. Civil Engineer). In other words, this would require a Civil Engineer to pass the Traffic Engineer exam to practice Traffic Engineering. Though this bill did not directly affect the Practice of Geotechnical Engineering, CalGeo joined ACEC in opposition to this bill based on principal. It was voted to die in committee on January 11, 2010.

AB 1431 is in committee at the time this article was written, and whether to allow it to go to the floor for debate is still pending. This bill will add the title Geologist to the Board for Professional Engineers and Land Surveyors and require that a Professional Geologist be added to the board for fair representation. Though CalGeo strongly believes that we are best served by having a separate board for the geology profession, we support this bill to bring fairness and representation to registered geologists in California.
